<u>Application for Multi Modal Integration for Last Mile Connectivity</u>

1. Background

- Provision of seamless, hassle-free, convenient, smooth and integrated first and last mile connectivity or feeder services at Metro stations, is one of the objectives of NMRC. The work on 21 Metro stations are close to completion and the Metro operations are scheduled to begin on these stations shortly.
- II. NMRC has an existing bus network which shall be integrated to the Noida-Greater Noida Metro Corridor. Further NMRC is also in the process of engaging E-Rickshaw player to deploy exclusive E-Rickshaws at the stations of the corridor.
- III. NMRC intends to initiate additional feeder services operations at its Metro stations.
- IV. To implement the integrated feeder services, NMRC invites the Application to select and engage the reputed Private Operators/ Aggregators/ Vendors/ Dealers/ Manufacturers to operate and maintain the small & medium capacity feeder services at the NMRC stations.
- V. NMRC invites Applicants ("Interested parties") to submit their Applications. Based on the responses of Applications received, NMRC shall finalize the terms and conditions and initiate the procedure.
- VI. The issue of this Application does not imply that NMRC is bound to undertake the Process and select the Applicant/s.

2. Eligibility of Applicants
